Table grapes, red varieties	1 – 2 pts/ac	Apply 2 times per season, at the beginning of color change with 10-20% colored berries and/ or 12° brix, repeat 7-10 days after the first application. Use 100 gal of water per acre if using an air-blast sprayer. Use 10-12 gal of water per acre if using an electrostatic sprayer. Table grapes, white varieties	1 pt/ac	Apply 2 times per season, at the beginning of color change and repeat 7 days after the first application. Use 100 gal of water per acre if using an air-blast sprayer. Use 10-12 gal of water per acre if using an electrostatic sprayer. Consult your Cultiva, LLC sales associate for more specific information on application rates for your local growing area and crop.
Citrus	1 pt/ac	Apply 3 weeks before harvest and repeat 2 weeks after the first application. Consult your Cultiva, LLC sales associate for more specific information on application rates for your local growing area and crop.
Cherries	1 – 2 pts/ac	Apply 5 to 7 days before harvest with enough water to obtain good coverage, avoid runoff. Consult your Cultiva, LLC sales associate for more specific information on application rates for your local growing area and crop.
Apples	1 – 2 pts/ac	Apply 1 or 2 times 30 days before harvest and repeat 7 to 15 days after the first application. Consult your Cultiva, LLC sales associate for more specific information on application rates for your local growing area and crop.
